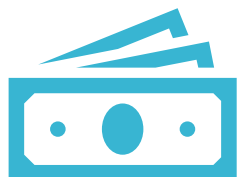


### **Acquiring knowledge**

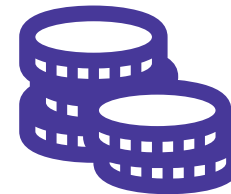

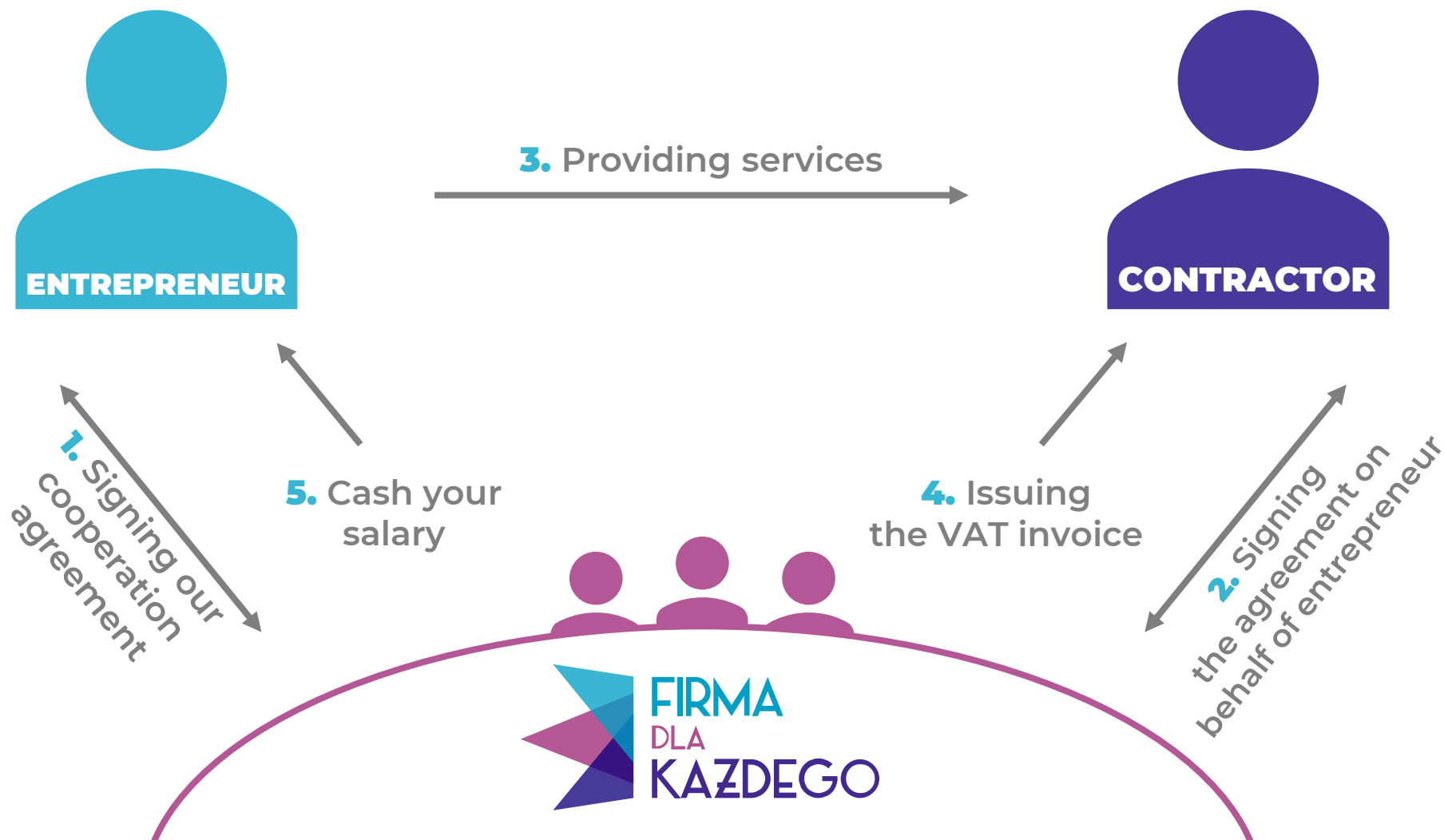

# FOUNDATION – CONTRACTOR – ENTREPRENEUR

## Step by step

### 1. Signing a cooperation agreement between foundation and entrepreneur

Our cooperation agreement is signed for indefinite period and can be terminated with one month notice.

### 2. Signing an agreement on behalf of your contractor

If your purchaser requires any contract, we are to sign it on behalf of each contractor. Beforehand, our law department is obliged to check the content and accept it.

### **Step by step**

#### **3. Providing services**

After first two steps, you can provide your services for your partner.

#### **4. Issuing the VAT invoice**

Using our online invoice system you can issue the sale invoice for your partner.

#### **5. Cash your salary**

After you get your payment, you can cash your salary deducting all taxes (VAT, PIT). You must generate all documents (contract and receipt) in our online system.
